Full Time flat rate tuition: \$13,080 (9-15 units) per term

Less than Full Time (fewer than 9 units) per term: \$1,090 per unit

Important Note for Current Students:

Graduate students actively enrolled during **Spring 2026** will be **grandfathered under the current policy** (6 units = Full Time) **provided continuous enrollment is maintained until program completion.**

- Online requests through the National Student Clearinghouse: \$10 per copy + \$2.90 ordering processing fee
- Offline requests: \$15 per copy
- Express Mail
 - United States (per address): \$39
 - Canada and Mexico (per address): \$59
 - International (per address): \$75

*Students who wish to register for courses after the Add Period must submit written approval (e-mail is acceptable) of the course instructor and a senior school administrator of the school in which the course is offered and pay a \$100 late fee. The fee is assessed only once per term regardless of the number of courses for which students register after the Add Period. The fee is assessed even if students are adding different sections of courses that they dropped in the same term.
